The couriers' delivery timeframes are usually:

2-3 working days to Auckland,

For rural area addresses, freight companies reserve the right to charge a surcharge where they deem necessary. In this case, if the original shipping fee charged is not sufficient to cover the Rural Delivery Surcharge to deliver to the customer's provided address, your order will be delivered to the nearest freight company depot address.
